EntryProtect prevents the uplifting of any sensitive data such as user names, passwords, credit card, bank account details and any other identity-based or sensitive data entered into a web-based application. As EntryProtect provides true end-to-end encryption of all transmitted data (beyond the scope of SSL), it also provides full protection against MITM and replay attacks.

The largest single dataroom transaction supported by ProjectFusion is valued at GBP8 billion and the largest dataroom run is 125Gb (over 3 million pages).

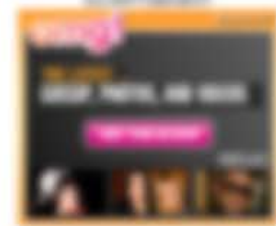
